William Pipolo, Jr. made a motion to close the previous meeting from March 24, 2021. The motion was seconded by John Seese and carried. All Supervisors voted aye. The meeting was called to order at 5:30 p.m. by Chairman William Pipolo, Jr.

- b. John Seese made a motion to open High Acres Park on Thursday, April 15, 2021. The motion was seconded by William Pipolo, Jr. and carried. All Supervisors voted aye.
- c. John Seese made a motion to approve the additional sign for the Veterans Memorial Garden at High Acres Park. The motion was seconded by William Pipolo, Jr. and carried. All Supervisors voted aye.
- d. William Pipolo, Jr. made a motion to accept and advertise the 2020 Audit Report from Kirk, Summa & Co., LLP. The motion was seconded by John Seese and carried. All Supervisors voted aye.

New Business:

- a. William Pipolo, Jr. made a motion to approve the payroll for March 23, 2021 in the amount of \$22,642.60 for gross wages, \$694.36 for state liability, \$5,796.20 for federal tax liability and \$17,597.93 for net wages. The motion was seconded by Patti O'Keefe and carried. All Supervisors voted aye.
- b. William Pipolo, Jr. made a motion to approve the purchase of a new plow for the Mack Truck in the amount of \$8,500.00 and to put the old plow on Municibid. The motion was seconded by Benjie LaBar and carried. All Supervisors voted aye.
- c. Discussion was held on the request to put in a shed at the C.A.M.E. Building for additional food storage. It was noted that the Boy Scouts would be moving from the basement of the C.A.M.E. Building to the Gunderson Property and the basement would be available for food storage.
- d. A letter was received from Michael O'Shea from the Buck Hill Falls Company requesting a five year extension on the Municipal Subdivision approval originally granted on March 24, 2009 for the Buck Hill Pheasant Lane Subdivision. William Pipolo, Jr. made a motion to table the extension until more information could be obtained. The motion was seconded by Patti O'Keefe and carried. All Supervisors voted aye.
