# Barrett Township Supervisors Minutes of Regular Meeting on April 27, 2022

A regular meeting of the Barrett Township Supervisors was held on Wednesday, April 27, 2022, at the Municipal Building on Route 390 in Mountainhome, PA. The meeting was called to order at 8:00 a.m. by Chairman Pam Gardsy.

Present: Pam Gardsy, Kelly Slinger, John Seese, Darryl Speicher, Jeryl Rinehart and the public. There were no public comments on the agenda items. Pam O'Keefe was absent.

The minutes of the April 13, 2022 Meeting and the April 20, 2022 Workshop Meeting were approved on a motion made by Pam Gardsy and seconded by Kelly Slinger and carried. All Supervisors voted aye.

Pam Gardsy made a motion to approve the payment of the following bills:
