Barrett Township Supervisors Wednesday, August 22, 2018

A regular meeting of the Barrett Township Supervisors was held on Wednesday, August 22, 2018 at the Barrett Township Building on Route 390 in Mountainhome, PA. The meeting was called to order at 8:00 a.m. by Chairman William Pipolo, Jr.

Present: Patti O'Keefe, William Pipolo, Jr., Grant Hilfiger, John Seese, Pam Gardsy, Jeryl Rinehart and the public. Benjie Labar was absent. There were no public comments on the agenda items.

William Pipolo, Jr. made a motion to approve the payment of the following bills:

- a. William Pipolo, Jr. made a motion to buy out the fire house copier for \$ 419.75, have it serviced and place it on Municibid. The motion was seconded by John Seese and carried. All Supervisors voted aye.
- b. A letter was received from Nicole Hilfiger resigning her position as Chairman of the High Acres Park Committee. William Pipolo, Jr. made a motion to accept the letter of resignation. The motion was seconded by John Seese. Grant Hilfiger abstained. All the other Supervisors voted aye.

- b. William Pipolo, Jr. made a motion to sign the letter of support for the Pocono Mountain Regional Police Department for a grant for video cameras for the police cars. The motion was seconded by Grant Hilfiger and carried. All Supervisors voted aye.
