# Barrett Township Supervisors Minutes of Regular Meeting on August 12, 2020

A regular meeting of the Barrett Township Supervisors was held on Wednesday, August 12, 2020 at the Municipal Building on Route 390 in Mountainhome, PA. John Seese made a motion to close the previous meeting from August 5, 2020. The motion was seconded by Benjie LaBar and carried. All Supervisors voted aye. The meeting was called to order at 5:30 p.m. by Vice Chairman Patti O'Keefe.

Present: Patti O'Keefe, Benjie LaBar, May LaBar, John Seese, Solicitor Todd Weitzmann, Pam Gardsy, Jeryl Rinehart and the public. William Pipolo, Jr. was absent. There were no public comments on the agenda items.

May Labar made a motion to rescind the motion to approve Ordinance No. 198, Zoning Ordinance Amendment because the advertising listed the wrong date for the Public Hearing. The minutes of the August 5, 2020 meeting were approved on a motion made by Patti O'Keefe and seconded by Benjie LaBar and carried. All Supervisors voted aye.

Patti O'Keefe made a motion to approve the payment of the following bills:

August 5, 2020 - General Fund - \$ 21,373.81, Park and Recreation Fund - \$ 2,455.42, Fire Fund - \$ 1,875.26, State Fund - \$ 349.50, Open Space Fund - \$ 1,336.26, Library Fund - \$ 191.23, Ambulance Fund - \$ 53.63

The motion was seconded by John Seese and carried. All Supervisors voted aye.

### Reports:

- a. The Treasurer's Report for July was read. On a motion made by May LaBar and seconded by Patti O'Keefe and carried, the report was accepted as read. All Supervisors voted aye.
- b. The Ambulance Report was read. There were 40 calls in Barrett Township bringing the year to date total to 257 and 570 total responses throughout all townships for the month of July with a year to date total of 3,467. On a motion made by Patti O'Keefe and seconded by May LaBar and carried, the report was accepted as read.
- c. The Roadmaster's Report for July was read. On a motion made by May LaBar and seconded by Benjie LaBar and carried, the report was accepted as read. All Supervisors voted aye.

#### **Old Business:**

- a. John Seese made a motion to adopt Ordinance No. 198, Zoning Ordinance Amendments. The motion was seconded by May LaBar and carried. All Supervisors voted aye. John Seese made a motion to close the Public Hearing for the Zoning Ordinance Amendments. The motion was seconded by May LaBar and carried. All Supervisors voted aye.
- b. John Seese made a motion to accept the bid from Vincent Piacente Electrical Contracting in the amount of \$8,575.00 for the electrical work at the Community Park at Ice Lake. The motion was seconded by May LaBar and carried. All Supervisors voted aye.

a. Patti O'Keefe made a motion to approve and sign the Non-Uniform Employee Pension Plan Minimum Municipal Obligation for 2021 in the amount of \$ 36,989.00. The motion was seconded by Benjie LaBar and carried. All Supervisors voted aye.

a. It was noted that no certificates of insurance were received.
