The meeting was called to order at 7:00 p.m. by Chairman Ralph Megliola. Present: Ralph Megliola, Loree Guthrie, Patti O'Keefe, Paul Stotsenburg, John Seese, Solicitor Todd Weitzmann, Chief Steve Williams, Jeryl Rinehart and the public.

Bills:

- b. The Police Report was read. On a motion made by Ralph Megliola and seconded by Paul Stotsenburg and carried, the report was accepted as read.
- c. The Roadmaster's Reports for October and November was read. On a motion made by Ralph Megliola and seconded by Paul Stotsenburg, the report was accepted as read.
- d. The Open Space Committee Report was reviewed. Ralph Megliola made motion to table the report until the report could be corrected. The motion was seconded by Paul Stotsenburg and carried. All Supervisors voted aye.

Old Business:

- d. Discussion was held on an email that was received from Judith Linder concerning changing the cut-off day for payroll in the new year so that payroll always reflects actual hours worked. It will be discussed further at the Reorganization Meeting.

a. It was noted that a certificate of insurance was received from Smoking Chef Catering.
