Barrett Township Supervisors February 24, 2016

A regular meeting of the Barrett Township Supervisors was held on Wednesday, February 24, 2016 at the Barrett Township Building on Route 390 in Mountainhome, PA. The meeting was called to order at 8:00 a.m. by Vice Chairman Loree Guthrie.

Present: Loree Guthrie, Benjie Labar, William Pipolo, Jr., John Seese, Pam Gardsy, Jeryl Rinehart and the public. Ralph Megliola was absent. There were no public comments on the agenda items.

Representatives from Keystone Compassionate Care were present to discuss the status of the medical marijuana legislation in Harrisburg, their desire to open dispensaries in the area when it is legalized and providing information on adopting a marijuana decriminalization ordinance.

- b. John Seese made a motion to adopt Resolution No. 22416A, appointing and authorizing Kirk, Summa &Co. to make an examination of all the accounts of Barrett Township for the fiscal year 2015 in lieu of the elected Board of Auditors, which will be retroactive from January 1, 2016. The motion was seconded by William Pipolo, Jr. and carried. All Supervisors voted aye.
- c. It was noted that the Conditional Use Hearing for Shirlene Eugene and Karamella Trumpaitzky, 119 Robinson Lane scheduled for Wednesday, February 24, 2016 has been cancelled and their application has been withdrawn.
- d. Loree Guthrie made a motion to accept the January meeting minutes for the E.A.C. and Open Space Committee as read. The motion was seconded John Seese and carried. All Supervisors voted aye.

The scholarship event will be held on Thursday, April 28, 2016 at 7:00 p.m. in Stroud Hall, Room 117 at the East Stroudsburg University.
- d. A letter was received from Boucher and James, Inc. concerning their review of the submitted plan for the Aqua PA, Inc., Oak Lane Water Main Replacement.
- e. It was noted that the 2016 Judicial Tax Sale list was received from the Monroe County Tax Claim Bureau.
- f. Loree Guthrie made a motion to adopt Resolution No. 22416, authorizing and appointing Secretary/Treasurer Pam Gardsy as the liaison between the Township and Berkheimer, appointed collector of local taxes. The motion was seconded by John Seese and carried. All Supervisors voted aye.
