# BARRETT TOWNSHIP SUPERVISORS MINUTES OF THE REORGANIZATION MEETING OF JANUARY 3, 2023

The Reorganization Meeting of the Barrett Township Board of Supervisors was held Tuesday, January 3, 2023, at the Barrett Township Municipal Building on Rte. 390 in Mountainhome, PA. The meeting was called to order at 9:00 a.m. by Chairman Pamela Gardsy.

Present: Pam Gardsy, Kelly Slinger, Patti O'Keefe, John Seese, Darryl Speicher, Solicitor Todd Weitzmann, Jeryl Rinehart and the public.

Solicitor Todd Weitzmann opened the floor to nominations for Chairman of the Board of Supervisors. Kelly Slinger made a motion to nominate Pam Gardsy, the motion was seconded by John Seese. As there were no other nominations for Chairman, the motion was carried, and all Supervisors voted aye.

Pam Gardsy opened the floor to nominations for Vice-Chairman of the Board of Supervisors. Pam Gardsy made a motion to nominate Patti O'Keefe as Vice-Chairman of the Board of Supervisors. The motion was seconded by Kelly Slinger. As there were no other nominations for the office of Vice-Chairman, the motion carried, and all Supervisors voted aye.

Pam Gardsy made a motion to set policy that all bills shall be paid at a public meeting except for certain recurring payments such as: contracts, payroll, discount bills, insurance, and interest payments. The motion was seconded by Kelly Slinger and carried. All Supervisors voted ave.

John Seese made a motion to authorize the Treasurer to issue a check in case of an item of immediate need to be secured by cash. The motion was seconded by Kelly Slinger and carried. All Supervisors voted ave.

John Seese made a motion to authorize the Treasurer to spend up to \$1,500.00 per month with the approval of one other Supervisor. The motion was seconded by Kelly Slinger and carried. All Supervisors voted aye.

Pam Gardsy made a motion to establish that Township employees will be paid at time and one-half of the hourly rate after 40 hours have actually been worked in accordance with the Fair Labor Standards Act. The motion was seconded by John Seese and carried. All Supervisors voted aye.

Pam Gardsy made a motion to establish that paydays shall be on a biweekly schedule, with each pay period ending on Tuesday and paychecks being distributed the next day. The first pay period shall end on Tuesday, January 10, 2023. The motion was seconded by Kelly Slinger and carried. All Supervisors voted aye.

Pam Gardsy made a motion that any advances in pay may be made by motion of the Board of Supervisors in the event of an emergency. The motion was seconded by Kelly Slinger and carried. All Supervisors voted aye.

Pam Gardsy made a motion that all full-time employees and full-time appointed positions will be paid for the following holidays:

New Year's Day, Martin Luther King, Jr. Day, Presidents' Day, Good Friday, Memorial Day, Juneteenth, Fourth of July, Labor Day, Columbus Day, Veterans Day, Thanksgiving Day, Day after Thanksgiving, ½ day Christmas Eve, Christmas Day, and ½ day New Year's Eve. The motion was seconded by Kelly Slinger and carried. All Supervisors voted aye. It was noted that if the holiday falls on a Saturday, the holiday will be observed on Friday, and if the holiday falls on a Sunday, the holiday will be observed on Monday.

Pam Gardsy made a motion that the Township will pay all group health insurance for full time employees hired prior to October 2017 and their families. Employees hired after October 2017, can add a spouse or family member but must cover 40 % of the additional premium through payroll deduction; The Township will cover 60 % of the difference in premium. The Supervisors will pay for the individual employees' dental coverage. If the employee wishes to add a spouse or family member, the Township will pay a cap of \$ 60.00 toward the cost of the premium. The motion was seconded by Kelly Slinger and carried. All Supervisors voted aye.

Pam Gardsy made a motion that all full-time employees and full-time appointed positions after completing one (1) year of service receive five (5) days paid vacation. After two (2) years of consecutive service, all full-time employees and full-time appointed positions will receive ten (10) days paid vacation. After completing five (5) years of consecutive service, all full time employees and full time appointed positions will receive fifteen (15) days of paid vacation. After completing fifteen (15) years of consecutive service, all full-time employees and full-time appointed positions will receive twenty (20) days of paid vacation. (terminated employees receive payment for unused vacation time on a pro-rata basis) Any remaining vacation days will be paid in the last pay period of the year. The motion was seconded by John Seese and carried. All Supervisors voted aye.

Pam Gardsy made a motion that each full-time employee and full-time appointed position, after one (1) year of service will receive four (4) personal days and one additional personal day after each ten (10) years of consecutive service. Each full-time employee and full-time appointed position will receive three (3) hours of sick time per month for a total of thirty—six (36) hours for the year 2022. There will be reimbursement of unused sick time up to a maximum of one hundred (100) hours upon termination of employment, appointment or retirement. The motion was seconded by John Seese and carried. All Supervisors voted aye.

It should be noted that a resolution was adopted by the Board of Supervisors on November 19, 1999, that the Barrett Township Board of Supervisors will pay medical insurance coverage for all full-time employees and their spouses upon their retirement as follows:

After completing 20 years of full time service – 50%

After completing 25 years of full time service – 100%

The medical insurance will be paid as stated above until Medicare takes over, at which time the Township will pay the co-insurance.

Pam Gardsy made a motion to appoint Kirk, Summa & Co. to do the 2022 Annual Audit. The motion was seconded by John Seese and carried. All Supervisors voted aye.

Pam Gardsy made a motion to authorize the Administrative Offices, in accordance with the Municipal Records Manual, to dispose of the following public records: Bank Statements and Vouchers from 2014. The motion was seconded by John Seese and carried. All Supervisors voted aye.

Pam Gardsy made a motion to adopt Resolution No. 010323 for covering the Barrett Township Fire Company under the workmen compensation insurance coverage for all Township activities that they participate in. The motion was seconded by Kelly Slinger and carried. All Supervisors voted aye.

The Minutes of the December 14, 2022 Meeting and the December 21, 2022 Workshop Meeting were approved on a motion made by Pam Gardsy and seconded by Kelly Slinger and carried. All Supervisors voted aye.

Pam Gardsy made a motion to approve the payment of the following bills:

## Subdivision/Land Development/Lot Consolidation:

a. The Applicant, Adam Campbell, is proposing to consolidate two lots (Lots 33 and 34, Section D of Lake in the Clouds) into one lot (new Lot 33A). The combined parcel area will be 1.062 acres. The existing lots have no development (currently vacant). A final review letter dated January 2, 2023, was received from Township Engineer Deanna Schmoyer, recommending approval of the lot combination plan. Darryl Speicher made a motion to approve the lot combination plan. The motion was seconded by John Seese and carried. All Supervisors voted aye.
