## Barrett Township Supervisors July 25, 2018

A regular meeting of the Barrett Township Supervisors was held on Wednesday, July 25, 2018 at the Barrett Township Building on Route 390 in Mountainhome, PA. The meeting was called to order at 8:00 a.m. by Chairman William Pipolo, Jr.

There were no public comments on the agenda items.

The minutes of the July 11, 2018 meeting were approved on a motion made by William Pipolo, Jr. and seconded by Grant Hilfiger and carried. All Supervisors voted aye.

William Pipolo, Jr. made a motion to approve the payment of the following bills:

- d. A email was received from Skytop Lodge requesting permission to hold the Fireworks Display for July 25, 2018 at 9:15 p.m. It was noted that the Fireworks Display was cancelled due to heavy rains.
- e. An invitation was received from the Barrett Paradise Friendly for Comedy Night featuring NYC's top Comics. It was noted that there was not a date for the event on the invitation.
- f. William Pipolo, Jr. made a motion to adopt Resolution No. 072518A for the Multimodal Transportation Grant. The motion was seconded by Patti O'Keefe and carried. All Supervisors voted aye.

a. It was noted that there was a certificate of insurance received from Pocono Mountain Regional Emergency Medical Services Inc.

John Seese made a motion to purchase a new snow plow for Truck No. 40 in the amount of \$8,655.00. The motion was seconded by William Pipolo, Jr. and carried. All Supervisors voted aye.

John Seese reported that the Caterpillar, D – 7 bull dozer was sold for \$ 50,000.00. The bulldozer was bought several years ago for \$ 5,500.00. There was a profit of \$ 44,500.00 with the sale of the bulldozer.
