

**Barrett Township Supervisors  
Minutes of Regular Meeting on March 24, 2021**

A regular meeting of the Barrett Township Supervisors was held on Wednesday, March 24, 2021 at the Municipal Building on Route 390 in Mountainhome, PA. William Pipolo, Jr. made a motion to close the previous meeting from March 10, 2021. The motion was seconded by John Seese and carried. All Supervisors voted aye. The meeting was called to order at 8:00 a.m. by Chairman William Pipolo, Jr.

**Present:** William Pipolo, Jr., Patti O'Keefe, May LaBar, Benjie LaBar, John Seese, Pam Gardsy, Jeryl Rinehart and the public.

There were no public comments on the agenda items.

The minutes of the March 10, 2021 Meeting were approved on a motion made by William Pipolo, Jr. and seconded by Benjie LaBar and carried. All Supervisors voted aye. The minutes of the March 17, 2021 Workshop Meeting were approved on a motion made by William Pipolo, Jr. and seconded by May LaBar and carried. All Supervisors voted aye.

William Pipolo, Jr. made a motion to approve the payment of the following bills:

- March 10, 2021 - General Fund - \$ 9,919.21, Park and Recreation Fund - \$ 672.95, State Fund - \$ 375.31, LST Fund - \$ 587.37

The motion was seconded by Benjie LaBar and carried. All Supervisors voted aye.

William Pipolo, Jr. made a motion to approve the payment of the following bills:

- March 17, 2021 - General Fund - \$ 40931.09, Park and Recreation Fund - \$ 704.35, Library Fund - \$ 3,534.23, Ambulance Fund - \$ 1,176.73, Fire Fund - \$ 3,502.97, State Fund - \$ 12,187.04, LST Fund - \$ 8,870.14, Open Space Grant Fund - \$ 2,400.00

The motion was seconded by May LaBar and carried. All Supervisors voted aye.

**Reports:**

a. The Roadmaster's Report for February was read. On a motion made by William Pipolo, Jr. and seconded by Benjie LaBar and carried, the report was accepted as read. All Supervisors voted aye.

b. The Police Report for February was read. On a motion made by William Pipolo, Jr. and seconded by May LaBar and carried, the report was accepted as read. All Supervisors voted aye.

c. The Treasurer's Report for February was read. On a motion made by William Pipolo, Jr. and seconded by Benjie LaBar and carried, the report was accepted as read. All Supervisors voted aye.

**Old Business:**

a. William Pipolo, Jr. made a motion to adopt Ordinance No. 199, the Blue Ridge Cable Franchise Agreement Ordinance. The motion was seconded by John Seese and carried. All Supervisors voted aye.

b. William Pipolo, Jr. made a motion to approve and sign the Letter of Support for the Brodhead Watershed Association for the grant application to the National Fish and Wildlife Foundation, Delaware River Program for Mill Creek. The motion was seconded by Patti O'Keefe and carried. All Supervisors voted aye.

c. It was noted that there will be Virtual Conference Workshops offered since the P.S.A.T.S. Conference was cancelled in April.

New Business:

a. William Pipolo, Jr. made a motion to approve the payroll for March 9, 2021 in the amount of \$ 16,110.81 for gross wages, \$ 493.83 for state liability, \$ 4,020.77 for federal tax liability and \$ 12,554.35 for net wages. The motion was seconded by May LaBar and carried. All Supervisors voted aye.

Correspondence:

a. A letter was received from The Friendly Community Center informing the Supervisors that they appreciate their donation and support.

Miscellaneous:

a. It was noted that no certificates of insurance were received.

High Acres Park Committee Member, Sonia White was present to discuss the possibility of having the Memorial Day Ceremony and the Veterans Day Ceremony, a Memorial Bench in memory of Cheri Jones and banners and signs for High Acres Park. The Memorial Day Ceremony will be discussed approximately a month prior to the ceremony to determine what the state guidelines are for gatherings due to COVID.

As there was no further business, William Pipolo, Jr. made a motion to recess the meeting at 8:46 a.m. The motion was seconded by John Seese and carried. All Supervisors voted aye.
