# Barrett Township Supervisors Minutes of Regular Meeting on March 25, 2020

A regular meeting of the Barrett Township Supervisors was held on Wednesday, March 25, 2020 at the Barrett Township Municipal Building on Route 390 in Mountainhome, PA. The meeting was called to order at 8:00 a.m. by Chairman William Pipolo, Jr.
