# Barrett Township Supervisors Minutes of Regular Meeting on May 13, 2020

A regular meeting of the Barrett Township Supervisors was held on Wednesday, May 13, 2020 at the Municipal Building on Route 390 in Mountainhome, PA. William Pipolo, Jr. made a motion to close the previous meeting from April 22, 2020. The motion was seconded by Benjie LaBar and carried. All Supervisors voted aye. The meeting was called to order at 5:30 p.m. by Chairman William Pipolo, Jr.

Present: William Pipolo, Jr., Patti O'Keefe, Benjie LaBar, May LaBar, John Seese, Pam Gardsy, Jeryl Rinehart, Solicitor Todd Weitzmann and the public. (Todd and the public were present through an internet conference).

There were no public comments on the agenda items.

The minutes of the April 22, 2020 meeting were approved on a motion made by William Pipolo, Jr. and seconded by Patti O'Keefe and carried. All Supervisors voted aye.

William Pipolo, Jr. made a motion to approve the payment of the following bills:

- April 22, 2020 General Fund \$ 2,087.64, Park and Recreation Fund \$ 335.00, State Fund \$ 2,216.65, Fire Fund \$ 1,776.76
- April 29, 2020 General Fund \$ 51,393.22, Ambulance Fund \$ 4,541.57, Library Fund \$ 13,638.70, Fire Fund \$ 1,150.00

The motion was seconded by John Seese and carried. All Supervisors voted aye.

## Reports:

- a. The Building (6), Zoning (4) and S.E.O. (0) Reports for April were read. On a motion made by William Pipolo, Jr. and seconded by Benjie LaBar and carried, the reports were accepted as read. All Supervisors voted aye.
- b. The Ambulance Report was read. There were 26 calls in Barrett Township bringing the year to date total to 139 and 382 total responses throughout all townships for the month of April with a year to date total of 2,089. On a motion made by William Pipolo, Jr. and seconded by Patti O'Keefe and carried, the report was accepted as read.

### **Old Business:**

a. It was noted that there was no Old Business.

### **New Business:**

a. William Pipolo, Jr. made a motion to approve the payroll for April 21, 2020 in the amount of \$22,354.18 for gross wages, \$685.52 for state liability, \$5,580.59 for federal tax liability and \$17,510.41 for net wages and for May 5, 2020 in the amount of \$33,833.84 for gross wages, \$1,037.94 for state liability, \$9,747.31 for federal tax liability and \$25,183.43 for net wages. The motion was seconded by Benjie LaBar and carried. All Supervisors voted aye.

### **Correspondence:**

a. A letter was received from PA DEP informing the Supervisors that they have reviewed and approved the April 10, 2020 request for a reduction in quarterly ground water monitoring from the Canadensis Gulf Station.

- b. A letter was received from PA DEP informing the Supervisors that they have approved the final report for the substances identified and remediated at 664 Lenape Lane.
- c. A letter was received from Entech Engineering notifying the Supervisors of their intention to file a PA DEP Public Water Supply Permit Application on behalf of Spruce Lake Retreat.
- d. A letter was received from PA DEP informing the Supervisors that they have determined that a heating oil release occurred at 6657 Route 191.

## Miscellaneous:

a. It was noted that a certificate of insurance was received from Millenia Home Improvements.

Discussion was held on purchasing the radios from Tu-Way Communications. It was noted that the radios were put in the budget for this year. Pam will request an updated quote from Tu-Way Communications.

John Seese reported that the old paver was sold on Muncibid for \$ 3,607. He also confirmed that the water problem at the C.A.M.E. building was corrected with a new water expansion tank.

It was also noted that the Township Cleanup will be on Saturday, June 6, 2020 from 8:00 a.m. – 12:00 p.m.

As there was no further business or public comment, William Pipolo, Jr. made a motion to recess the meeting at 5:58 p.m. The motion was seconded by John Seese and carried. All Supervisors voted aye.
