A regular meeting of the Barrett Township Supervisors was held on Wednesday, May 26, 2021 at the Municipal Building on Route 390 in Mountainhome, PA. The meeting was called to order at 8:00 a.m. by Vice Chairman Patti O'Keefe

- a. The Police Report for April was read. On a motion made by Patti O'Keefe and seconded by May LaBar and carried, the report was accepted as read. All Supervisors voted aye.
- b. The High Acres Park Committee Meeting Minutes for May 6, 2021 were read and discussed. On a motion made by Patti O'Keefe and seconded by John Seese and carried, the report was accepted as read.
- c. The Fire Chief's Report for April was read. On a motion made by Patti O'Keefe and seconded by May LaBar and carried, the report was accepted as read. All Supervisors voted aye.

Subdivision/Land Development/Lot Combination:
