Barrett Township Supervisors November 14, 2018

A regular meeting of the Barrett Township Supervisors was held on Wednesday, November 14, 2018 at the Barrett Township Building on Route 390 in Mountainhome, PA. The meeting was called to order at 5:30 p.m. by Chairman William Pipolo, Jr.

- c. The Ambulance Report was read. There were 32 calls for the month of October, 414 total calls for the year and total company responses for October were 536 and 5607 year to date. On a motion made by William Pipolo, Jr. and seconded by Patti O'Keefe and carried, the report was accepted as read.

- a. William Pipolo, Jr. made a motion to approve the payroll for October 23, 2018 in the amount of \$ 16,254.12 for gross wages, \$ 498.23 for state liability, \$ 4,124.42 for federal tax liability and \$ 12,623.76 for net wages. The motion was seconded by John Seese and carried. All Supervisors voted aye.
- b. A letter was received from the Monroe County Conservation District informing the Supervisors that they conducted an inspection of earth disturbance activities at the Activity Center at Spruce Lake Retreat.
- c. William Pipolo, Jr. made a motion to accept the 2019 Draft Annual Budget for P.A.R.C. The motion was seconded by Grant Hilfiger and carried. All Supervisors voted aye.
- d. A letter with the proposed 2019 Operating Budget was received from the Monroe County Control Center. - e. William Pipolo, Jr. made a motion to approve the Fireworks Permit for Skytop Lodge on Monday, December 31, 2018 at 10:30 p.m. The motion was seconded by Grant Hilfiger and carried. All Supervisors voted aye.
- f. A copy of a letter was received from PA DEP informing the Supervisors that they have determined that a heating oil release occurred at 2866 Route 390. The letter was sent to the property owner informing them that they are required to investigate the extent of the environmental impact and then perform a cleanup.
- g. Brian McCann and Deanna Berger were present to discuss building a skate park at High Acres Park. Brian and Deanna will looked into the cost of insurance, speak with other Townships who have skate parks and talk with Shawn McGlynn, Building Code Officer to determine what is required to build the skate park.
- h. William Pipolo, Jr. made a motion to approve the 2019 Police Budget in the amount of \$ 519,282.30 . The motion was seconded by Benjie Labar and carried. All Supervisors voted aye.
