A Special Meeting of the Barrett Township Supervisors was held on Wednesday, November 18, 2020 at the Municipal Building on Route 390 in Mountainhome, PA. William Pipolo, Jr. made a motion to close the previous meeting from October 28, 2020. The motion was seconded by Benjie LaBar and carried. All Supervisors voted aye. The meeting was called to order at 8:00.m. by Chairman William Pipolo, Jr.

c. The Treasurer Report for October was read. On a motion made by William Pipolo, Jr. and seconded by May LaBar and carried, the report was accepted as read. All Supervisors voted aye.

They can start as early as mid-December depending on the weather and that will be the mobilization of their equipment and starting the removal of the top part of the bridge and the bridge will be completed by September. Pam will send a letter to the neighbors informing them of the schedule.

William Pipolo, Jr. made a motion for the year 2020 that Jeryl Rinehart's inspection fees will remain at 50% and she will be reimbursed the septic fees for 2020. The motion was seconded by Patti O'Keefe and carried. John Seese abstained. All other Supervisors voted aye.

Patti O'Keefe reported the revenue for the P.M.E.M.S. is down by 9% and they are managing by doing less maintenance on the ambulances and fuel savings to cut costs.

Patti O'Keefe also reported that there was timbering done on the State Game Lands by Ice Lake and she contacted some people and found out that they timbered 139 acres for the habitat and it is a standard game land practice to start regrowth of the trees.

At 9:13 a.m., Judy Linder joined the meeting by Zoom access to discuss the 2021 Budget.
