# Barrett Township Supervisors Minutes of Regular Meeting on September 22, 2021

A regular meeting of the Barrett Township Supervisors was held on Wednesday, September 22, 2021, at the Municipal Building on Route 390 in Mountainhome, PA. William Pipolo, Jr. made a motion to close the Supervisors Meetings from Wednesday, September 15, 2021. The motion was seconded by John Seese and carried. All Supervisors voted aye. The meeting was called to order at 8:00 a.m. by Chairman William Pipolo, Jr.

There were no public comments on the agenda items.

- a. The Police Report for August was read. On a motion made by William Pipolo, Jr. and seconded by Benjie LaBar and carried, the report was accepted as read. All Supervisors voted aye.
- b. The Roadmaster's Report for August was read. On a motion made by William Pipolo, Jr. and seconded by May LaBar and carried, the report was accepted as read. All Supervisors voted aye.
- c. The Fire Chief's Report for August was read. On a motion made by William Pipolo, Jr. and seconded by Benjie LaBar and carried, the report was accepted as read. All Supervisors voted ave.
- d. The Ambulance Report was read. For the month of August, PMR EMS responded to 57 incidents in Barrett Township bringing the year-to-date total to 306. Overall, for the month of August, PMR EMS responded to a total of 606 incidents throughout all townships which brings the year-to-date total to 4,473. - d. William Pipolo, Jr. made a motion to approve the purchase of the Dell Security SonicWALL in the amount of \$ 663.28 to upgrade the internet speed. The motion was seconded by May LaBar and carried. All Supervisors voted aye.

### **Correspondence:**

- a. A letter was received from Austin James Associates, Inc. informing the Supervisors that the Land Recycling and Environmental Remediation Standards Act require that a Notice for the submittal of a Remedial Investigation/Final Report be provided to the Township for the Buck Hill Falls, former Garage and Maintenance Areas.
- b. A letter was received from Tyrex Resources informing the Supervisors that due to the significant increase in fuel prices, tremendous increase in labor costs and the additional costs associated with maintaining state and PA DEP compliance, they will be instituting a market-wide passenger tire increase starting on September 13, 2021. The last tire pick up amount was \$ 534.00. Adjusting for the upcoming price increase, that same pick up amount would have been \$ 801.00, representing an increase of \$ 267.00.

# Miscellaneous:

a. It was noted that a certificate of insurance was received for Stone Ridge Diesel LLC.

Pam Gardsy reported that the 5K Scarecrow Race will not be held this year due to COVID restrictions.

Pam also reported that a new account will need to be opened for the money received from the American Rescue Plan Funding.

Patti O'Keefe reported that grant money was received for the renovations at the Pocono Mountain Regional Emergency Medical Services in Tobyhanna.
