Barrett Township Supervisors Wednesday, September 26, 2018

A regular meeting of the Barrett Township Supervisors was held on Wednesday, September 26, 2018 at the Barrett Township Building on Route 390 in Mountainhome, PA. The meeting was called to order at 8:00 a.m. by Chairman William Pipolo, Jr.

Present: Benjie Labar, Patti O'Keefe, William Pipolo, Jr., Grant Hilfiger, John Seese, Pam Gardsy, Jeryl Rinehart and the public.
There were no public comments on the agenda items.

The minutes of the September 12, 2018 meeting were approved on a motion made by William Pipolo, Jr. and seconded by Patti O'Keefe and carried. All Supervisors voted aye.

William Pipolo, Jr. made a motion to approve the payment of the following bills:

- September 12, 2018: General Fund \$ 6,593.97, Library Fund \$ 198.21, Fire Fund \$ 2,695.00, Ambulance Fund \$ 66.07, Open Space Fund \$ 180.00, State Fund 202,496.74, Park and Recreation Fund \$ 1,727.98
- September 19, 2018: General Fund \$ 33,425.32, Fire Fund \$ 38,914.94, State Fund \$ 1,222.40, Park and Recreation Fund \$ 265.00

The motion was seconded by Grant Hilfiger and carried. All Supervisors voted aye.

Reports:

a. The Roadmaster's Report was read. On a motion made by William Pipolo, Jr. and seconded by Grant Hilfiger and carried, the report was accepted as read.

Subdivision/Land Development:

a. The Estate of Dana Weiss and Christopher and Hazel Gifford Final Minor Subdivision and Lot Consolidation Plan, Martin and Robbins Surveying – It was noted that the Planning Commission recommended approval of the plan on April 4, 2018, contingent on the property tax issue being resolved. The property taxes were paid in full on September 20, 2018. William Pipolo, Jr. made a motion to approve the subdivision plan. The motion was seconded by Benjie Labar and carried. All Supervisors voted aye.

Old Business:

a. William Pipolo, Jr. made a motion to renew and sign the two year traffic signal maintenance contract with Signal Service Inc. The motion was seconded by

- c. A letter was received from PennDot notifying the Supervisors that the estimated Liquid Fuels allocation for 2019 is \$ 203,226.48.

New Business:

William Pipolo, Jr. made a motion to approve the payroll for September 11, 2018, in the amount of \$ 14,045.87 for gross wages, \$ 430.44 for state liability, \$ 3,416.58 for federal tax liability and \$ 10,995.80 for net wages. The motion was seconded by Benjie Labar and carried. All Supervisors voted aye.
- b. William Pipolo, Jr. made a motion to approve the donation of \$ 50.00 to Lehigh Valley Visiting Nurses and Hospice in memory of Patti Dente. The motion was seconded by John Seese and carried. All Supervisors voted aye.
- c. William Pipolo, Jr. made a motion to approve the Fireworks Permit for Skytop Lodge on Saturday, October 20, 2018, contingent on the time meeting the Ordinance No. 194 requirements. The motion was seconded by Benjie Labar and carried. All Supervisors voted aye.
- d. A letter was received from the Monroe County Conservation District informing the Supervisors that they conducted an inspection of earth disturbance activities at the Chestnut Grove Village.
- e. A letter was received from the Monroe County Conservation District informing the Supervisors that they conducted an inspection of earth disturbance activities at the Bandala Yard Extension.

Miscellaneous:

a. It was noted that there were no certificates of insurance received.
