A regular meeting of the Barrett Township Supervisors was held on Wednesday, September 9, 2020 at the Municipal Building on Route 390 in Mountainhome, PA. William Pipolo, Jr. made a motion to close the previous meeting from August 26, 2020. The motion was seconded by May LaBar and carried. All Supervisors voted aye. The meeting was called to order at 5:30 p.m. by Chairman William Pipolo, Jr.

There were 43 calls in Barrett Township bringing the year to date total to 300 and 581 total responses throughout all townships for the month of August with a year to date total of 4,048. On a motion made by William Pipolo, Jr. and seconded by Patti O'Keefe and carried, the report was accepted as read.
- c. The Roadmaster's Report for August was read. On a motion made by William Pipolo, Jr. and seconded by May LaBar and carried, the report was accepted as read. All Supervisors voted aye.
- d. The Building (6), Zoning (6) and S.E.O. (3) Reports for August were read. On a motion made by William Pipolo, Jr. and seconded by John Seese and carried, the reports were accepted as read. All Supervisors voted aye.
- e. The Fire Chief's Report for July was read. On a motion made by William Pipolo, Jr. and seconded by May LaBar and carried, the report was accepted as read. All Supervisors voted aye. a. Correspondence:

a. A letter was received from the Monroe County Municipal Waste Authority asking the Supervisors to be involved in the Keep America Beautiful's Cigarette Litter Prevention Program. Discussion was held on posting no smoking sign in place of the containers and the maintenance required to empty the containers. May LaBar made a motion that we not participate in the Program. The motion was seconded by William Pipolo, Jr. and carried. All Supervisors voted aye.

b. A letter was received from Pennoni Associates, Inc. informing the Supervisors that they were intending to submit a national Pollutant Discharge Elimination System (NPDES) permit Application to the Northeast Regional Office of Pennsylvania Department of Environmental Protection for the renewal of the existing discharge permit for Blue Ridge Peat Farm, Inc.

Miscellaneous:

a. It was noted that certificates of insurance was received from Centre Concrete Northeast LLC.

Mrs. Genova asked if the Townships could get together and hire someone with a truck to remove the tent caterpillars along the highways. It was suggested for Mrs. Genova to contact Monroe County Vector Control to discuss removing them.

William Pipolo, Jr. made a motion to recess the meeting and go into Executive Session at 5:43 p.m. to discuss litigation and personnel matters. The motion was seconded by May LaBar and carried. All Supervisors voted aye.
