A regular meeting of the Barrett Township Supervisors was held on Wednesday, December 23, 2020 at the Municipal Building on Route 390 in Mountainhome, PA. William Pipolo, Jr. made a motion to close the previous meeting from December 16, 2020. The motion was seconded by John Seese and carried. All Supervisors voted aye. The meeting was called to order at 8:00.m. by Chairman William Pipolo, Jr.

William Pipolo, Jr. made a motion to approve the payment of the following bills:

Reports:

a. The Roadmaster's Report for November was read. On a motion made by William Pipolo, Jr. and seconded by May LaBar and carried, the report was accepted as read. All Supervisors voted aye.

Subdivision/Land Development/Lot Combination:

a. Lisa A. Mathena and Donna M. Girod, Lake in the Clouds, Lot 7-G and 8-G, Lot Combination Plan – The plan was submitted by Trout Creek LLC. It was noted that Township Engineer Deanna Schmoyer reviewed the lot combination plan and recommended approval. William Pipolo, Jr. made a motion to approve the lot combination plan contingent on receiving the updated plan and Jeryl Rinehart and Deanna Schmoyer reviewing the plan. The motion was seconded by Benjie LaBar and carried. All Supervisors voted ave.

Unemployment Compensation Group Trust Fund have voted to pay a dividend to participating townships who have a commendable claims ratio for 2019 and are current in the filing of their quarterly reports. A dividend check in the amount of \$ 122.39 was received.

a. It was noted there were no certificates of insurance were received.
