**Approved the minutes of the September 18, 2018 meeting.** Motion by Kathleen Sandt, seconded by Patti O'Keefe.

**Open space maintenance year end recommendations:**

**Gravel Family Preserve:** Mow the large field behind dog park to encourage blueberry and huckleberry growth and control encroaching gray birch. This can be done at any time the field is snow free. The vegetation may be close cut to the ground and can be done between the first killing frost and the onset of leaf pop in spring. Keep Parking area plowed for access to dog park and trails for winter recreation such as cross country skiing.

**Pasold Farm Nature Preserve:** Plow the first parking area to allow access to trail.

**Mount Wismer:** Plow to allow access to trails.

**Ice Lake:** Plow to allow access to trails.

**Reorganization:** All current members of the EAC would like to continue to serve in 2019.

**High Acres Park discussion:**

There is apparently a roadside drainage issue causing water to impound at the memorial site at high Acres Park. It has apparently been like this for several years. Unfortunately, it means that the memorial site is periodically inundated with water as it was during the Veteran's day service on November 11. The EAC recommends that the Township look into the cause of the inundation and finding a remedy for that prior to adding fill at the site.

The proposed skateboard park at High Acres is a request to convert the old basketball courts along the middle branch of the Broadhead Creek. The EAC is not against the development of a skateboard park but the location of the old basketball court is a concern.

The EAC would like to recommend that the skateboard park be constructed farther away from the stream, say next to the beach volleyball court, or even better at 7 Pines which was purchased as an active recreation site. The old basketball court should be restored to a forested riparian buffer that will add to the ecosystem functions of the stream and protect water quality.
