# Barrett Township Supervisors Minutes of Regular Meeting on October 12, 2022

A regular meeting of the Barrett Township Supervisors was held on Wednesday, October 12, 2022, at the Municipal Building on Route 390 in Mountainhome, PA. The meeting was called to order at 5:30 p.m. by Vice Chairman Patti O'Keefe.

Present: Kelly Slinger, Patti O'Keefe, John Seese, Darryl Speicher, Solicitor Todd Weitzmann, and the public. Pam Gardsy and Jeryl Rinehart were absent.

There were no public comments on the agenda items.

The minutes of the September 28, 2022 Meeting and the minutes of the October 3, 2022 Special Meeting were approved on a motion made by Patti O'Keefe and seconded by Kelly Slinger and carried. All Supervisors voted aye.

Patti O'Keefe made a motion to approve the payment of the following bills:

- September 28, 2022 General Fund \$ 15,367.16, Park and Recreation Fund \$ 85.00, Open Space Fund \$ 85.00, Library Fund \$ 77.83, Ambulance Fund \$ 25.92
   The motion was seconded by Kelly Slinger and carried. All Supervisors voted aye.
   Patti O'Keefe made a motion to approve the payment of the following bills:
  - October 5, 2022 General Fund \$ 64.20, Park and Recreation Fund \$ 1600.00, Fire Fund - \$ 300.00

The motion was seconded by Kelly Slinger and carried. All Supervisors voted aye.

## Reports:

- a. The Treasurer's Report for September was read. On a motion made by John Seese and seconded by Kelly Slinger and carried, the report was accepted as read. All Supervisors voted aye.
- b. The Ambulance Report was read. For the month of September, PMR EMS responded to 51 incidents in Barrett Township bringing the year-to-date to 432. PMR EMS responded to a total of 555 incidents in September bringing the year-to-date to 5,320. On a motion made by John Seese and seconded by Darryl Speicher and carried, the report was accepted as read. All Supervisors voted aye.

## Old Business:

- a. John Seese made a motion to hire Janine Sopko for the Administrative Assistant part-time position. The motion was seconded Kelly Slinger and carried. All Supervisors voted aye.
- b. John Seese made a motion to authorize the signing of the Agreement of Sale to purchase the former Barrett Elementary Center. The motion was seconded by Patti O'Keefe and carried. All Supervisors voted aye.

#### **New Business:**

a. Kelly Slinger made a motion to approve the payroll for October 10, 2022, in the amount of \$21,772.38 for gross wages, \$668.39 for state liability, \$4,974.75 for federal tax liability and \$17,461.77 for net wages. The motion was seconded by Patti O'Keefe and carried. All Supervisors voted aye.

- c. John Seese made a motion to approve the allocation of 2500 gallons of fuel per year to be split between diesel and gasoline for the Pocono Mountain Regional Emergency Medical Services. The motion was seconded by Patti O'Keefe and carried. All Supervisors voted aye.

- a. A letter was received from the Monroe County Meals on Wheels thanking the Supervisors for holding the Household Essentials Drive at the Municipal Building.
- b. A letter was received from the Barrett Paradise Friendly Library thanking the Supervisors for their help installing the Tale on the Trail at Ice Lake.

a. It was noted that a certificate of insurance was received from O'Leary Construction, LLC.
