# Barrett Township Supervisors Minutes of Regular Meeting on October 28, 2020

A regular meeting of the Barrett Township Supervisors was held on Wednesday, October 28, 2020 at the Municipal Building on Route 390 in Mountainhome, PA. William Pipolo, Jr. made a motion to close the previous meeting from October 14, 2020. The motion was seconded by John Seese and carried. All Supervisors voted aye. The meeting was called to order at 8:00.m. by Chairman William Pipolo, Jr.
