

AN ORDINANCE NO. 105

AN ORDINANCE PROVIDING FOR COMPENSATION OF  
SUPERVISORS ELECTED AFTER NOVEMBER 7, 1989

The following ordinance is hereby adopted by the Board of Supervisors of Barrett Township:

WHEREAS the General Assembly of the Commonwealth of Pennsylvania has enacted Act 68 of 1985 setting forth certain guidelines and limitation for the compensation of Supervisors of Townships of the Second Class, and

WHEREAS said Act provides that Supervisors of Townships having a population of not more than 4,999 shall be compensated in an amount not to exceed \$1,500.00, and

WHEREAS the population of Barrett Township is approximately 3,273, and

WHEREAS the General Assembly by said Act 68 authorizes the Boards of Supervisors of the various Townships of the Second Class to determine the compensation of Supervisors subject to the limitation set forth in the Act.

Now therefore it is hereby enacted and ordained as follows:

2. Such compensation shall be paid in quarterly installments.

3. This Ordinance shall be effective upon enactment.

Enacted into an Ordinance this 11th day of April, 1990.

The following ordinance is hereby adopted by the Board of Supervisors of <sup>BARLETT</sup>~~Pocono~~ Township:

Whereas the General Assembly of the Commonwealth of Pennsylvania has enacted Act 68 of 1985 setting forth certain guidelines and limitation for the compensation of Supervisors of Townships of the Second Class, and

Whereas said act provides that Supervisors of Townships having a population of <sup>NOT MORE THAN 4,999</sup>~~5,000 to 9,999~~ shall be compensated in an amount not to exceed <sup>1,500.00</sup>~~\$2,000.00~~, and

Whereas the population of <sup>BARLETT</sup>~~Pocono~~ Township is approximately <sup>3,273</sup>~~5,782~~, and

Whereas the General Assembly by said Act 68 authorizes the Boards of Supervisors of the various Townships of the Second Class to determine the compensation of Supervisors subject to the limitation set forth in the act.

Now therefore it is hereby enacted and ordained as follow:

1. Each Supervisor of ~~Pecono~~ <sup>BALLETI</sup> Township elected or appointed to office on or after November <sup>7</sup> ~~7~~, 198~~9~~, shall receive compensation as a Supervisor in the annual amount of <sup>1,080.00</sup> ~~\$2,000.00~~, *BASED ON 27 MEETING PER YEAR @ 40.00 PER MEETING*
2. Such compensation shall be paid in ~~monthly~~ <sup>QUARTERLY</sup> installments.
3. This Ordinance shall be effective ~~January 1, 1986.~~
