ORDINANCE NO. 111

AN ORDINANCE OF THE TOWNSHIP OF BARRETT, MONROE COUNTY,  
PENNSYLVANIA, AUTHORIZING AN AMENDMENT TO THE AGREEMENT  
DATED DECEMBER 10, 1986 BETWEEN THE TOWNSHIP OF BARRETT  
AND THE PENNSYLVANIA MUNICIPAL RETIREMENT BOARD TO  
AUTHORIZE THE WAIVING OF REQUIRED MEMBER CONTRIBUTIONS FOR  
THE CALENDAR YEAR 1992 AND TO ORDINANCE NO. 106 WHICH  
AUTHORIZED THE WAIVING OF REQUIRED MEMBER CONTRIBUTIONS  
FOR THE CALENDAR YEAR 1991.

NOW THEREFORE, BE IT ORDAINED AND ENACTED by the Supervisors  
of the Township of Barrett as follows:

SECTION I. The proper officers of the Township of Barrett  
are hereby authorized and directed to execute all documents and to do  
all other acts that may be necessary and proper to amend the Agreement  
dated December 10, 1986 between the Township of Barrett and the  
Pennsylvania Municipal Retirement Board to authorize the waiving of  
required member contributions for the calendar year 1992 for members  
participating in the police pension plan.


SECTION II. A duly certified copy of this ordinance amending  
Ordinance 106 which authorized the same for calendar year 1991 shall  
be filed with the Pennsylvania Municipal Retirement Board of the  
Commonwealth of Pennsylvania.

SECTION III. In the event any provision, section, sentence,  
clause or part of this ordinance shall be held to be invalid, such  
invalidity shall not affect or impair any remaining provision,  
section, sentence, clause or part of this ordinance, it being the  
intent of this Township that such remainder of this ordinance shall be  
and shall remain in full force and effect.

SECTION IV. This ordinance shall become effective January  
1, 1992.

ADDENDUM

THIS ADDENDUM made as of this 13 day of DEC, 1991, by and between the Township of Barrett (hereinafter referred to as the "Township") and the PENNSYLVANIA MUNICIPAL RETIREMENT BOARD (hereinafter referred to as the "Board").

WITNESSETH:

WHEREAS, on December 10, 1986, the Township and Board entered into an Agreement (hereinafter referred to as the "Agreement") which provides a retirement and disability pension plan for certain police officers of the Township; and

WHEREAS, Paragraph 10 of the Agreement requires that each member contribute five percent (5%) of their compensation; and

WHEREAS, the Township and the Board desire to modify Paragraph 10 of the Agreement to authorize the waiving of required member contributions for the calendar year 1992;

NOW THEREFORE, with the foregoing background incorporated herein by reference and made a part hereof, the Township and the Board, in consideration of the mutual promises and obligations set forth herein and intending to be legally bound hereby, agree as follows:

1. Paragraph 10 of the Agreement dated December 10, 1986 between the Township and the Board is hereby amended to read as follows:

"10. Contribution by Members: A member shall contribute five percent (5%) of his total compensation in a manner consistent with Board established policy; provided, however, for the calendar year 1992 only, members shall not be required to contribute to the funding of the plan. Said funding shall be assumed by the Township.

If a member terminates prior to becoming eligible for any benefit, or should a member elect not to receive a benefit, all accumulated contributions personally contributed, interest and credited excess interest shall be returned to the member."


2. This addendum shall become effective January 1, 1992.

3. It is the clear and unequivocal intent of the Township and the Board that this Addendum shall in no manner alter or affect the rights or obligations of the Township and the Board as set forth in the Agreement dated December 10, 1986, other than to modify Paragraph 10 in the manner set forth above.
