ORDINANCE NO. 151

AN ORDINANCE OF THE TOWNSHIP OF BARRETT, COUNTY OF MONROE, AND COMMONWEALTH OF PENNSYLVANIA, AMENDING BARRETT TOWNSHIP ORDINANCE NO. 125 AND ESTABLISHING STATUTORY 25 MILES PER HOUR SPEED LIMITS FOR MOTOR VEHICLES ON CERTAIN ROADWAYS WITHIN BARRETT TOWNSHIP.

WHEREAS, Act 1998-151, Act of December 21, 1998, P.L. 1126, No. 151, found at 75 Pa.C.S. §3362(a)(1.2) and §3363, authorizes Pennsylvania municipalities, subject to 75 Pa.C.S. § 6109(e), to set the speed limit at twenty-five (25) miles per hour on certain roads without a prior engineering and traffic investigation; and

WHEREAS, certain roads exist within Barrett Township, a Pennsylvania second class township (the "Township"), where no speed limits have been established or where conditions warrant a reduction of the speed limits previously adopted; and

WHEREAS, the Board of Supervisors of Barrett Township deems it to be in the best interests, and for the general welfare, of the citizens and residents of the Township to enact twenty-five (25) miles per hour speed limits on certain roads in the Township pursuant to Act 1998-151;

WHEREAS, the within Ordinance is intended to amend existing Barrett Township Ordinance Number 125 by establishing 25 MPH speed limits on additional Township roads.

BE IT ORDAINED AND ENACTED by the Board of Supervisors of Barrett Township, Monroe County, Pennsylvania, pursuant to the general powers permitted by the Second Class Township Code (53 P.S. § 65101) and the above mentioned authority, the following:

SECTION 1. – TITLE.

This Ordinance shall be known and may be cited as the "Barrett Township Statutory 25 MPH Speed Limit Ordinance Amendment."

SECTION 2. – MAXIMUM SPEED LIMITS ESTABLISHED ON CERTAIN ROADS.

The following speed limits are hereby established on the roads indicated:

<u>Road</u>	<u>Location</u>	<u>Speed Limit</u>
Preacher Hill Road (SR 616)	0.40 miles from Oak Lane to Spruce Cabin Road	25
Rolla Road (SR 631)	0.20 miles from Ridge Road to Oak Ridge Lane	25
Oak Ridge Lane (SR 625)	0.29 miles from Prices Drive to Spruce Cabin Road	25
Ridge Road (SR 630)	0.06 miles from Oak Ridge Lane to Rolla Road	25

SECTION 3. – ENFORCEMENT.

This Ordinance shall be enforced by the Barrett Township Police Department or any other authorized police officer in accordance with the provisions of the Vehicle Code of Pennsylvania as it pertains to fines and other penalties.

SECTION 4. – SEVERABILITY.

The provisions of this Ordinance are severable. If any sentence, clause or section is for any reason found to be unconstitutional, illegal or invalid, such decision shall not affect the validity of any of the remaining provisions of this Ordinance. It is hereby declared as the legislative intent that this Ordinance would have been adopted had such unconstitutional, illegal or invalid provisions had not been included herein.

SECTION 5. – REPEALER.

All ordinances or parts of ordinances in conflict herewith shall be and the same are hereby repealed.

SECTION 6. – EFFECTIVE DATE.

This Ordinance shall take effect five (5) days after the date of its enactment.
