**ORDINANCE NO. 177**

**AN ORDINANCE OF THE TOWNSHIP OF BARRETT, COUNTY OF MONROE, AND COMMONWEALTH OF PENNSYLVANIA, ESTABLISHING A STATUTORY 25 MILES PER HOUR SPEED LIMIT FOR MOTOR VEHICLES ON HIGH ROAD AND LOW COURT IN BARRETT TOWNSHIP.**

**BE IT ORDAINED AND ENACTED** by the Board of Supervisors of Barrett Township, Monroe County, Pennsylvania, pursuant to the general powers permitted by the Second Class Township Code (53 P.S. § 65101) and Act 1998-151, Act of December 21, 1988, P.L. 1126, No. 151 (75 Pa.C.S.A. § 3362(a)(1.2) and §3363), the following:

**SECTION 1. – TITLE. -**

This Ordinance shall be known and may be cited as the “Statutory Speed Limit Ordinance for High Road and Low Court.”

**SECTION 2. – MAXIMUM SPEED LIMIT ESTABLISHED. -**

A maximum speed limit of twenty-five (25) miles per hour is hereby established on the entire length of High Road and Low Court, as set forth on the attached traffic study report and sketch plan prepared by Boucher & James, Inc., Consulting Engineers, dated 10/21/2013, last revised 10/29/2013, which are attached hereto as Exhibits 1 and 2, respectively, and incorporated by reference.

**SECTION 3. – SEVERABILITY. -**

The provisions of this Ordinance are severable. If any sentence, clause or section is for any reason found to be unconstitutional, illegal or invalid, such decision shall not affect the validity of any of the remaining provisions of this Ordinance. It is hereby declared as the legislative intent that this Ordinance would have been adopted had such unconstitutional, illegal or invalid provisions had not been included herein.

**SECTION 4. – REPEALER. -**

All ordinances or parts of ordinances in conflict herewith shall be and the same are hereby repealed.

**SECTION 5. – EFFECTIVE DATE. -**

This Ordinance shall take effect five (5) days after the date of its enactment.


