

ORDINANCE NO. 41

AN ORDINANCE APPROVING AGREEMENT DATED AS OF FEBRUARY 1, 1962 BETWEEN MOUNT POCONO AIRPORT AUTHORITY AND THE BOROUGH OF MOUNT POCONO, THE TOWNSHIPS OF BARRETT, COOLBAUGH, PARADISE, POCONO AND TOBYHANNA; AND AUTHORIZING EXECUTION AND DELIVERY OF SAID AGREEMENT ON BEHALF OF THE TOWNSHIP OF BARRETT

BE IT ENACTED AND ORDAINED by the Board of Supervisors of the Township of Barrett, Monroe County, Pennsylvania, and it is hereby enacted and ordained by authority of the same as follows:

SECTION 1. The Agreement dated as of February 1, 1962, between Mount Pocono Airport Authority and the Borough of Mount Pocono, the Townships of Barrett, Coolbaugh, Paradise, Pocono and Tobyhanna, providing for the extension of the Agreement and Lease, dated as of August 1, 1958, between the Authority, as Lessor, and the aforesaid Municipalities, as Lessees, and the Management Agreement, dated as of August 1, 1958, between the Authority and the aforesaid Municipalities, for a period of six (6) years beginning November 30, 1965 and ending November 29, 1971, and the payment of certain rentals by said Municipalities to said Authority during said extended term, be and hereby is approved in the form submitted at this meeting of the Board of Supervisors.

SECTION 2. The Chairman, or the Vice Chairman, of the Board of Supervisors be and hereby is authorized to execute said Agreement on behalf of the Township, and the Secretary of the Board of Supervisors be and hereby is authorized and directed to affix the seal of the Township thereto and to attest the same, and when so executed, sealed and attested, to deliver said Agreement on behalf of the Township.
