

BARRETT TOWNSHIP SUPERVISORS ORDINANCE NO. 46

WHEREAS, the Supervisors have been endowed by law to ordain such actions as might be necessary for the protection of the public health, welfare and safety, pursuant to the Act of 1933, May 1, Public Law 103, Article VII, Section 702, as amended, and

WHEREAS, the establishment of certain motor vehicle speed limits is both necessary and proper for the maintenance of the public health, safety and welfare,

NOW, THEREFORE, BE IT ORDAINED AND ENACTED as follows:

1. A twenty-five mile motor vehicle speed limit is hereby established on the following roads:

(a) Route 596 and 605 (Price's Drive) from State Road 390 to Route 606 (Oak Lane).

(b) Route 596 and 615 (Laurel Pine Drive) from State Road 390 to Route 606 (Oak Lane).

(c) Route 606-624-616 (Oak Lane) from State Road 390 to Route 605 (Price's Drive).

This ordination is pursuant to the authority vested in the Supervisors by the Legislature of the Commonwealth of Pennsylvania and has been duly advertised as required by law.
