

**Barrett Township Supervisors
Minutes of Regular Meeting on January 6, 2025**

A regular meeting of the Barrett Township Supervisors was held on Monday, January 6, 2025, at the Municipal Building on Route 390 in Cresco, PA. The meeting was called to order at 9:36 a.m. by Chairman Pam Gardsy.

Present: Pam Gardsy, Kelly Slinger, Darryl Speicher, John Seese, Patti O'Keefe, Jeryl Rinehart and the public. Solicitor Todd Weitzmann was absent.
There were no public comments on the agenda items.

The Minutes of the December 18, 2024 Meeting were approved on a motion made by Pam Gardsy and seconded by Darryl Speicher and carried. All Supervisors voted aye.

Pam Gardsy made a motion to approve the payment of the following bills:

- December 18, 2024 - General Fund - \$ 84,134.78, Park and Recreation Fund - \$ 2,171.56, State Fund - \$ 603.77, Open Space Fund - \$ 6,770.55, Library Fund - \$ 888.63, Ambulance Fund - \$ 295.89, Fire fund - \$ 2,950.39
- December 30, 2024 - General Fund - \$ 6,013.18, LST Fund - \$ 2,024.62, Library Fund - \$ 195.39, Ambulance Fund - \$ 65.03

The motion was seconded by Kelly Slinger and carried. All Supervisors voted aye.

Reports:

a. The S.E.O. (1), Zoning (14) and Building (11) Reports for December were read. On a motion made by Pam Gardsy and seconded by Kelly Slinger and carried, the reports were accepted as read. All Supervisors voted aye.

Old Business:

a. It was noted that the Auditors' Reorganization Meeting is scheduled for Tuesday, January 7, 2025, at 7:00 p.m.

New Business:

a. Pam Gardsy made a motion to approve the payroll for December 24, 2024, in the amount of \$ 22,838.67 for gross wages, \$ 701.14 for state liability, \$ 4,757.01 for federal tax liability and \$ 18,080.76 for net wages. The motion was seconded by Kelly Slinger and carried. All Supervisors voted aye.

Correspondence:

a. It was noted that the 2024 Annual Report for the Pocono Mountains Economic Development Corporation was received.

Miscellaneous:

a. It was noted that a certificate of insurance was received from Bolognese Electric, Inc.

Discussion was held on having a meeting with the employees to discuss the revised Employees' Handbook.

Discussion was held on organizing the files to have easier access to them. Patti O'Keefe and Kelly Slinger volunteered to help organize the subdivision and land development files.

Discussion was held on the Supervisors attending the P.S.A.T.S. Conference in May.
